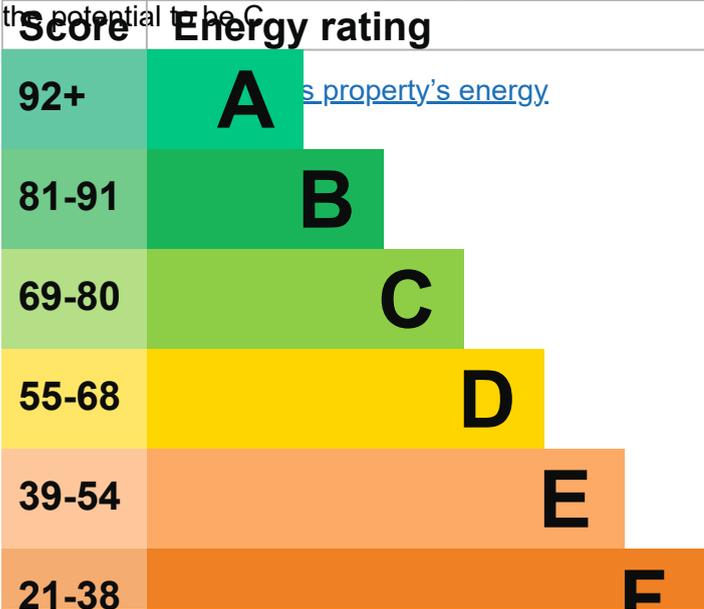

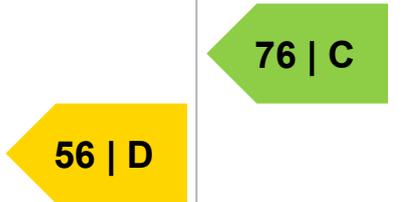
This property's current energy rating is D. It has the potential to be C.
